Note to the reader

The latest available consolidated trade data at EU level cover market developments in June 2024. Monthly figures can be compared with the previous month. Year-on-year change compares the cumulative trade since the beginning of the year with the same period in the previous year.

The trade figures are expressed in values, except when specifically mentioned. The unit value is the average price of products traded in the period concerned (trade value at the border divided by quantity registered).

HIGHLIGHTS: EU agri-food surplus increased in the first half of 2024

EU agri-food trade surplus increased by 15% in June 2024 compared to the previous month, with a value of EUR 5.8 billion. It remains however 10% below its level of June 2023. Supported by a strong beginning of the year, EU surplus reached EUR 33.7 billion between January and June 2024, an increase of EUR 1.5 billion compared to the same period in 2023.

EU exports reached EUR 18.9 billion in June 2024, 5% lower than the previous month and 4% lower than in June 2023. In the first half of the year, EU exports reached EUR 116.4 billion, just 1% above the same period in 2023. EU export increased significantly for olives and olive oil due to increased prices compared to 2023. On the other hand, exports decreased in value for vegetable oils and cereals. EU exports to the US increased the most, while exports in direction of China and Russia decreased.

EU imports decreased by 12% month-on-month in June and reached EUR 13 billion, 1% lower than in June 2023. Cumulative imports on the first half of 2024 reached EUR 82.7 billion, at a stable level compared to 2023. Import values for cocoa products increased compared to 2023 due to higher prices, while those of oilseeds and cereals decreased. Imports from Côte d'Ivoire had the largest increase in value, while those from Australia had the largest reduction.

EU AGRI-FOOD EXPORTS

EU EXPORTS REMAIN STEADY IN 2024, DESPITE REDUCTION IN JUNE

EU agri-food exports reached EUR 18.9 billion

in June 2024, a 5% reduction month-on-month and 4% lower than in June 2023. Cumulative exports since January reached EUR 116.4 billion, a small increase on 2023 (+1%, +EUR 1.1 billion).

The **US** was the destination with the largest increase of EU exports in the first half of the year compared to 2023 (+EUR 1 billion, +8%). This is largely explained by an increase in prices of olives and olive oil's exports.

EU exports to the **UK** increased by EUR 569 million (+2%) over the first half of the year compared to 2023, spread across a variety of products, despite a reduction in June.

EU exports also increased in direction of **Brazil** by EUR 209 million (+18%, mainly due to increased prices of olives and olive oil) and by 60% to **Lebanon** (+EUR 179 million, including a strong increase of sugar exports).

On the other hand, EU exports to **China** declined by 9%, -EUR 689 million, between January and June 2024 compared to 2023. This is mainly explained by reductions in several EU main exported products to China, in particular: pigmeat, dairy products and cereal preparations.

EU exports to **Russia** decreased by EUR 551 million (-15%) compared to 2023, due to reduced exported volumes across many categories, in particular spirit and liqueurs.

OLIVE OIL DROVE EU EXPORTS IN THE FIRST HALF OF 2024


EU exports of **olives and olive oil** increased the most compared to 2023 (+EUR 1.4 billion, +58%), mainly due to high prices while volumes remained stable.

Exports in the **coffee, tea, cocoa and spices** category also increased by EUR 822 million (+20%), mainly explained by higher prices and volumes exported of cocoa products.

Exports of **sugar and isoglucose** have increased by 146% (+EUR 435 million), as volumes exported have nearly tripled (+180%), while prices decreased by 12%.

On the other hand, the value of EU **cereals** exports decreased by EUR 1.1 billion (-14%), however this is explained by a reduction of prices by 20% compared to 2023. Total volumes exported actually increased by 8% compared to 2023, to reach 25.1 million tonnes in the first half of the year. This is mainly due to higher exports of wheat (+18%, +2.7 million tonnes), despite a reduction for corn (-32%, -740 thousands tonnes).

Exports of **vegetable oils** also decreased by EUR 737 million (-36%), due to both reduced prices and volumes (-20%). EU exports of **wine and wine based products** decreased by EUR 498 million (-6%), due to lower prices and volumes.



EU AGRI-FOOD IMPORTS

EU IMPORTS DECREASED IN JUNE 2024

The value of EU agri-food imports reached EUR 13 billion in June. It is a 12% reduction compared to the previous month but just 1% lower than in June 2023. Cumulative imports over the first half of the year reached EUR 82.7 billion, at a stable level compared to 2023 (-EUR 491 million).

Imports originating from **Côte d'Ivoire** had the largest increase (+EUR 951 million, +46%). This is mainly explained by higher prices of cocoa products. They were followed by imports from **Nigeria** which also increased significantly, by 132% (+EUR 473 million) for the same reason.

Imports from **Tunisia** had the third largest increase in value, as they more than doubled with an increase of EUR 419 million (+107%), mainly due to increased olive oil imported volumes and prices.

On the other hand, a steep reduction in imports could be observed from **Australia** (-EUR 843 million, -46%), due to a reduction in rapeseed imported volumes.

Brazil remained the first source of EU agri-food imports, despite having the second largest reduction in EU imports (-EUR 634 million, -7%), mainly due to lower oilseeds prices and a fall of corn imports.

Imports also decreased from **Indonesia** (-EUR 489 million, -17%, mainly due to reduced palm oil imports), as well as from **Canada** (-EUR 462 million, -28%, mainly due to lower corn and wheat imports).

COCOA IMPORT PRICES REMAIN HIGH, THOSE OF CROPS HAVE DECLINED

Imports of **coffee, tea, cocoa and spices** had the largest increase (+EUR 2.8 billion, +27%), mainly explained by high prices of cocoa products. Imports of **fruit and nuts** also grew by EUR 808 million (+7%), due to both increased volumes and prices.

Cumulative imports of **olives and olive oil** more than doubled in value, increasing by EUR 608 million (+132%) compared to 2023, due to both increased volumes and prices.

On the other hand, imports of **oilseeds and protein crops** had the largest reduction in value compared to 2023, with a decrease of EUR 2.1 billion (-18%), due to a reduction in imported prices, while imported volumes remained stable.

Imports of **cereals** also decreased by EUR 1.7 billion (-26%), due to reduced prices (-20%) and volumes (-8%, -1.5 million tonnes). Imports of **sugar and isoglucose** decreased by EUR 459 million (-40%), due to reduced imported volumes.


